

Revised Advisory dated 17-07-2020 for Masters Students 2018-2020 Batch

The following revised advisory is issued taking into consideration current prevailing COVID-19 outbreak in India and safety of all the students and residents of NIPER-SAS Nagar:

1. The students may visit NIPER-SAS Nagar to collect their belongings as per the schedule notified on 02-07-2020.
2. Students must comply strictly with COVID-19 related guidelines issued by NIPER and the State/Central Government from time to time.
3. All the students must mandatorily download and register on Arogya Setu and COVA App on their mobiles before entering in NIPER. All the students must wear mask compulsorily all the time.
4. In no circumstances students shall be allowed to stay on NIPER campus **for more than 3 hours between 9 am to 3 pm from Monday-Thursday** (irrespective of students from Punjab/local or other states) and no request/plea will be entertained in the matter.
5. **Students have to make their own arrangements for stay etc. and no accommodation will be provided inside the campus.**
6. 'No dues' can be cleared by the concerned department or through examination section by issuing the 'no dues certificate' to the students after getting desired information from all the concerned departments/ sections for any pending dues against the concerned students, who are completing their tenure as on 30.06.2020.
7. In case if any student wants to collect his/her belongings through their relative/friend/local guardian, an authorization letter needs to be provided. In such cases only person with the authorization will be allowed to enter NIPER campus.
8. Students must check the status of containment zone according to State/Central Govt. guidelines before start of their journey.
9. Students must make prior arrangement before coming to NIPER, for packing/ transportation of their vehicles (motorbikes, bicycles etc.) and Air Coolers installed in their rooms.
10. All requests be addressed to niperhostels@niper.ac.in with a copy to respective hostel warden and SEO with date of arrival at NIPER well in advance.
