 - 1.1 The work is estimated to cost **Rs. 2.98 Lakh**. This estimate, however, is given merely as a rough guide.
 - 1.2 Contractors who fulfill the following requirements shall be eligible to apply. Joint ventures are not accepted
 - 1.2.2 To become eligible, the bidders shall have to furnish an affidavit as under:-
 - 1.2.3 Satisfactorily completed 02 similar works for Construction of Net Practice Cricket Pitch in any govt./Private organizations in last 7 years ending previous day of last date of submission of bids. (**Similar Works shall mean "Construction of Net Practice Cricket Pitch"**). (Proofs are to be attached).
 - 1.2.4 The bidders should have Valid PAN No. (Proofs are to be attached).
 - 1.2.5 The bidders should have Certificate of Registration for GST. (Proofs are to be attached).
 2. The time allowed for carrying out the work will be **Two months** from the date of award of order.
3. The bid document consisting of plans, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents except General Conditions of Contract Form can be seen on website <http://tenderwizard.com/NIPER> and official website of the NIPER, S.A.S. 4. After submission of the bid the contractor can re-submit revised bid any number of times but before last time and date of submission of bid as notified.
5. While submitting the revised bid, contractor can revise the rate of one or more item(s) any number of times (he need not re-enter rate of all the items) but before last time and date of submission of bid as notified.
6. When bids are invited in three stage system and if it is desired to submit revised financial bid then it shall be mandatory to submit revised financial bid. If not submitted then the bid submitted earlier shall become invalid.

9. The description of the work is as follows:

"Construction of Net Practice Cricket Pitch at NIPER, S.A.S. Nagar".

10. Director, NIPER, S.A.S. Nagar does not bind itself to accept the lowest or any other bid and reserves to itself the authority to reject any or all the bids received without the assignment of any reason. All bids in which any of the prescribed condition is not fulfilled or any condition including that of conditional rebate is put forth by the bidders shall be summarily rejected.
11. Canvassing whether directly or indirectly, in connection with bidders is strictly prohibited and the bids submitted by the contractors who resort to canvassing will be liable for rejection.
12. Director, NIPER, S.A.S. Nagar reserves to himself the right of accepting the whole or any part of the bid and the bidders shall be bound to perform the same at the rate quoted.
13. The contractor shall not be permitted to bid for works in the Institute's Engineering Department (responsible for award and execution of contracts) in which his near relative is posted as Divisional Accountant or as an officer in any capacity between the grades of Assistant Engineer (both inclusive). He shall also intimate the names of persons who are working with him in any capacity or are subsequently employed by him and who are near relatives to any gazette officer in the Institute. Any breach of this condition by the contractor would render him liable to be removed from the approved list of contractors of NIPER
14. No Engineer or other officers employed in Engineering or Administrative duties in Institute is allowed to work as a contractor for a period of one year after his retirement from Institute's service without the previous permission of the competent authority in writing. This contract is liable to be cancelled if either the contractor or any of his employees is found at any time to be such a person who had not obtained the permission of the competent authority as aforesaid before submission of the tender or engagement in the contractor's service.
15. The bid for the works shall remain open for acceptance for a period of Ninety (90) days from the date of opening of bids. If any bidders withdraws his tender before the said period or issue of letter of acceptance, whichever is earlier, or makes any modifications in the terms and conditions of the bid which are not acceptable to the department, then the Institute shall, without prejudice to any other right or remedy, be at liberty to forfeit 50% of the said earnest money as aforesaid. Further the bidders shall not be allowed to participate in the rebidding process of the work.
16. **SIGNING OF CONTRACT**
The successful tenderer/ contractor, on acceptance of his tender by the Accepting authority shall, within 15 days from the stipulated date of start of the work sign the contract consisting of:
 - i) The notice inviting tender, all the documents including drawings if any forming the tender as issued at the time of invitation of tender and accepting thereof together with any correspondence leading thereto.

SECTION V	General Terms and Conditions	
-----------	-------------------------------------	---

1. The Agency should have GST registration No. Proof of GST registration is required to be attached for verification.
2. The rates shall be quoted in the enclosed Schedule of Quantities and it should be signed by the Contractor.
3. Earnest Money Deposit (EMD) total amounting Rs. 5960/- should invariably be deposited in the prescribed manner in favour of Director, NIPER.(online only)
4. The Agencies registered MSME, GOI, New Delhi shall be exempted for submission of EMD.
5. The rates shall be quoted in the enclosed Schedule of Quantities and it should be signed by the Contractor.
6. Defect Liability Period shall be **01 year** from the date of completion of work. The Security @ 5% shall be deducted from RA bill/ Final Bill which will be refunded after completion of defect liability period.
7. Rates to be inclusive of all taxes, GST, duties, royalty and labour cess etc. and nothing extra shall be payable.
8. The warranty shall be 01 year from the date of handed over of site to NIPER, S.A.S. Nagar. Any defects/ damages to Net Practice Cricket Pitch found during the warranty period shall be repaired/ replaced/ rectified by the Agency free of cost and cost of materials/labour etc. required for replacement of defective parts shall be borne by the Agency.
9. The Security Deposit @ 5% of the gross amount of the bill shall be deducted from each RA bill of the contractor till the sum will amount to Security Deposit of 5% of the tendered value of the work. The earnest money that is deposited at the time of tender shall be treated as part of the Security Deposit. The Agency can convert the Security Deposit in the form of FDR for warranty period.
10. Installation/ fixing and carriage charges should be inclusive in the rates.
11. The offer will remain valid for 90 days from the last date of submission of quote.
12. The period for execution of work is **02 months** from the date of issuing of Work Order/LOI.
13. Any clarification required to be sought may be obtained from Engineering Section, NIPER before due date of submission of quotation.
14. No escalation in rates shall be allowed under any circumstances during the execution of work and extension of time, if any.
15. The contractor shall comply with all the statutory requirements in respect of said work.
16. The contractor shall deemed to have visited the site and made themselves familiar with the working conditions before submitting the tender irrespective of the fact whether they inspect the site or not.
17. Water shall be arranged by Agency. However, in case, institute's water is used, water charges @ 1% of the amount of work done will be deducted from each RA bill/final bill.
18. Electricity if available will be provided at one point and will be charged as per actual consumption. However the contractor is required to make his own arrangement by installation of generator at his own cost to cope up any eventuality in the interest of progress of work.
19. The quantity in BOQ are tentative and there may be variation which may increase/decrease up as per CPWD norms.
20. The work shall be executed as per CPWD/manufacture specifications. The specifications of works other than specified in Schedule of Quantities will confirm to CPWD specifications/ latest Indian Standard Specifications.
21. All precautions as per CPWD safety code for the safety of workers and necessary health and sanitary arrangements for them will be taken by the Agency.

22. Material required for testing will be provided by the contractor at his own expenses. The tests considered necessary by the Engineer-in-Charge shall be got carried out by the contractor at his own expenses in recognized testing laboratory in the presence of Engineer-in-Charge or his authorized representative.
23. The contractor shall at his own cost and expense provide all materials required for the work. It is responsibility of contractor that the required material, when brought to site, shall be got entered/recorded by the Contractor at Main Security Gate, NIPER, S.A.S Nagar.
24. The samples of material to be used shall be deposited by the contractor with the Engineer-in-Charge before commencement of work.
25. Measurement of work done should be as per units specified in Schedule of Quantities. Measurements of any other item not indicated in Schedule of Quantities but required to be executed will be as per CPWD specifications.
26. In case the contractor fails to complete the work within the stipulated/extended time period, the penalty @ 1.5% per week of the cost of the total work subject to maximum 10% of the work order value will be levied on the Agency.
27. Payment will be released on the basis of RA bill/Final Bill to be put up by the Agency on the basis of actual work done subject to the condition that only one bill will be paid in a month, final bill will be cleared within three months of its submission subject to fulfillment of requisite criteria concerning execution of this work as per terms of Work Order.
28. The rate for all items of work, shall unless clearly specified otherwise include cost of all labour, materials and inputs involved in the execution of the item.
29. In case of any loss or damage to the property of the institute which is attributable to the firm, the full damages will be recovered from the firm.
30. In case of any mis-happening/ loss of life, the Agency has to bear all the claim and responsibility etc and the NIPER will not be responsible for any kind of payment to workers or contractor under these circumstances.
31. In case of Dispute/Arbitration between the Agency and NIPER, S.A.S Nagar related to said contract, the matter shall be referred to the Sole Arbitrator appointed by NIPER, SAS Nagar. Under such circumstances, the decision of the Sole Arbitrator shall be final and binding in any respect of any dispute between the parties.
32. The decision of the Director, NIPER, S.A.S. Nagar shall be the final and binding on the contractor/ agency in respect of any clause not covered under the contract and any matter incidental to the contract.
33. The Director, NIPER reserve the right to cancel the awarded work with immediate effect without assigning reasons.
